<b>LICENCE</b>	EFC licence obligatory for all U23. Licences are ordered by the national federations.
<b>FORMULA</b>	1 round of pools, direct elimination without repechage.
<b>EQUIPMENT</b>	FIE equipment obligatory. Equipment will be directly checked on the pistes.

Referees must be present at the meeting held prior to the events. Names of referees must be notified when entries are done.
